Considering the work done by the Treasury Board to maintain pay equity, the parties agree as follows:

I- The annual salary scale and rates found in clause 6-5.03, in subclause B) of clause 6-7.02 and in subclause A) of clause 11-2.02 are repealed and replaced by the following annual salary scale and rates:

1) Clause 6-5.03 is replaced by the following:

Article 10-15.00: Retroactivity resulting from the maintenance of pay equity is added to IIthe 2010-2015 agreement.

"10-15.01

This article applies to a full-time or part-time teacher, a teacher-by-the-lesson and to an hourly paid teacher.

10-15.02

1) Subject to the amounts paid under article 10-14.00, a teacher shall be entitled to receive a retroactive amount based on the duration of his or her service equal to the difference between:

the salary that he or she should have received as of December 31, 2010 up to the date on which the new salary scale and rates are paid;

and

- the salary that he or she was paid during that same period.

Except for the teacher referred to subclause 2) of this clause, the amounts owing shall be paid no later than September 30, 2011.

- 2) A teacher whose employment ended between December 31, 2010 and the date on which the retroactive amounts are paid must submit to his or her former employer a written request for payment so that the amounts owing are paid to him or her.
- 3) Any amount owing to a teacher under this article shall be payable, where applicable, to his or her beneficiaries, under the same conditions as those prescribed under subclause 2) of this clause.
- 4) The amounts calculated under this article shall bear interest at the legal rate in accordance with the Pay Equity Act (R.S.Q., c. E-12.001)."

III- Coming into force

This agreement comes into force on the date it is signed.
